As part of the Electric Utility Industry Sustainable Supply Chain Alliance's (Alliance) goal to promote sustainability in the industry's supply base, suppliers to the electric utility industry are being provided an opportunity to showcase their sustainable business operations, products and/or services at the fifth Utility Alliance Sustainability Forum.

Suppliers' showcased operation, product or service will go through a set of pre-established evaluation criteria by Alliance representatives prior to approval.

Each supplier will pay a fee of \$995. This fee includes one(1) registration to attend the educational sessions, receptions, breakfast and lunch. The display set up will include a 6' table covered, two chairs and a trash can to participate. Electricity is at an additional cost.

Submitted showcased operation, product or service will be reviewed for:

- Quantified reduced environmental impacts
- Cost savings
- · Length of time that impacts/savings captured
- Innovative ideas

Preference will be given to operational practices, products or services which conserve multiple resources (water, air, land, and/or energy) in their creation, use or practice. **Note:** Suppliers who wish to display based on their participation in an energy audit, environmental assessment or LEED certification without implementing identified savings opportunities will not be approved for display, unless other sustainable best practices exist.

Request to showcase must be received prior to Friday, August 25 for consideration. Space is limited. Approvals or denials are considered final and in some cases, may be based on space limitations or other venue based criteria.
